Roma firmly believes that our community will become better, with contributions from every one of us!

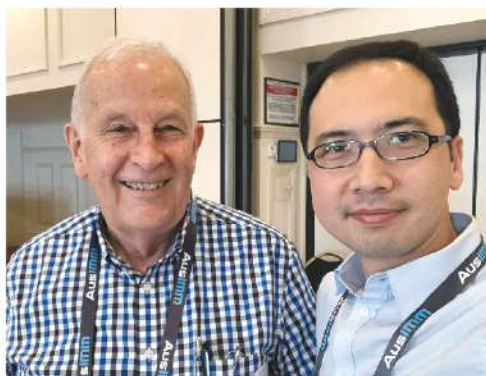

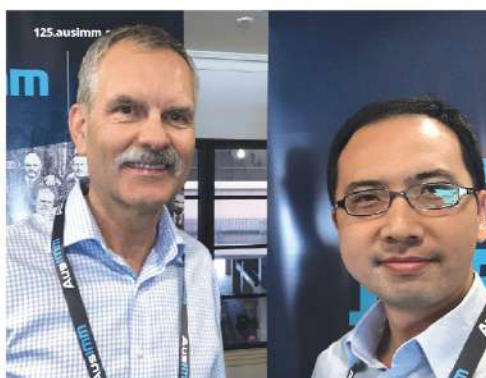


Professional Exchange
