# ESG Anti-corruption Seminar 2025

11 November 2025

We are pleased to share that more than **70 participants from over 20 listed companies** joined the **Anti-Corruption Seminar organised by Roma**, where our guest speakers Ms. Diana Liu, Deputy Regional Officer (Kowloon and Sai Kung) from the ICAC, and Mr. Kelvin Li, Partner at CFN Lawyers LLP, shared their valuable insights during a 1.5 hours session.

Ms. Liu discussed the roles of the Board and senior management in integrity governance, as well as possible conduct that may raise suspicions of bribery. Mr. Li then presented the concept and mechanisms of money laundering, emphasising that suspects may not be aware of their involvement in such crimes. His presentation also included the latest cases that further enhanced participants' understanding of the topic. This seminar helps participants identify actions that could expose them to legal risks.

Roma has calculated and offset the carbon emissions generated from organising this training by purchasing high-quality carbon credits. The offset covers emissions from venue electricity consumption, participant commuting and refreshment provision.
