# Highlighte ESG Seminar 2025

Date: 10 July 2025 (Thursday) Time: 16:00 - 17:00 We are excited to recap our recent seminar, co-organised with EBSI Private, entitled "From Macro Trends to Sustainable Finance: Global Market Outlook with Recent Trends in ESG & Climate Disclosures in Hong Kong", which attracted nearly 50 participants from various sectors.

Mr. Bill Tsang, Roma's Head of ESG, shared valuable insights on his team latest research on the ESG disclosure of some 80 Hang Seng Index constituent companies. The research reveals significant progress in ESG reporting such as:



the use of global reporting framework and science-based decarbonisation target commitments



an increase in climate scenario analysis



The presentation also highlighted that while a majority of these large-cap companies are disclosing scope 3 emissions data, some do not specify the figures for each category and instead lump them

into a single total. This indicates room for improvement in the granularity of reporting. Additionally, while carbon offsetting and the purchase of Renewable Energy Certificates (RECs) are present, they are less prevalent.

Roma has calculated and offset the carbon emissions associated with organising this seminar using quality carbon credits, covering aspects such as venue electricity, participant commuting, and food and drinks.



This report showcases our continued progress in advancing environmental and social responsibility, reflecting our commitment to creating long-term value for stakeholders.

**Accelerated** Advanced our science-based target to reduce Scope 1 and 2 greenhouse gas **Climate Goals** ("GHG") emissions by 70% (from 50%) by 2029/30, using the same baseline Offset over 50% of Scope 1 and 2 GHG emissions and 100% of travel-Continuing related Scope 3 emissions through the purchase and retirement of quality **Carbon Offsetting** carbon credits **Expanded** Voluntarily disclosed five Scope 3 categories (1, 2, 5, 6, and 7), enhancing **Scope 3 Reporting** transparency of our emission profile Climate Applied initial quantification methods to assess climate-related risks and **Scenario Analysis** opportunities, strengthening our resilience **Transition Plan** Progressing towards a comprehensive transition plan aligned with **Development** international frameworks **GRI Standards** Reported "in accordance with" the Global Reporting Initiative ("GRI") Compliance standards and continued to engage a third party for GHG data assurance
